



**THE DISTRICT 181 FOUNDATION'S
"BELIEVE IN GREEN" ENVIRONMENTAL EXPOSITION**

Non-Profit Exhibitor Agreement

This Non-Profit Exhibitor Agreement is by and between _____ (hereinafter "Non-Profit Exhibitor") and Elementary School District 181 Foundation (hereinafter "the Foundation"), an Illinois not for profit and charitable corporation. In consideration of the mutual promises contained in this Agreement, the receipt and sufficiency of which are hereby acknowledged, Non-Profit Exhibitor and the Foundation agree as follows:

1. APPEARANCE Non-Profit Exhibitor agrees to be present at the Foundation's "Believe in Green" Environmental Exposition ("the Event"), to be held at The Clarendon Hills Middle School, 301 Chicago Avenue, Clarendon Hills, IL. 60514 on Saturday, April 10, 2010 from approximately 10 a.m. to 3:00 p.m.

2. INFORMATION OR PRODUCT OFFERINGS On the date of the Event, Non-Profit Exhibitor shall provide information or environmentally friendly merchandise, products or equipment which falls within the parameters of the Event's overall theme. Non-Profit Exhibitor shall provide information, product(s) and set up necessary display(s) in advance of the 10:00am opening of the Event; assume responsibility for executing all facets of information distribution and/or sale transactions including, but not limited to, credit card charge acceptance and sufficient staff numbers to provide quick customer checkout; provide simple packaging for all items sold; and remove excess inventory and display materials from the Event site at the conclusion of the Event day.

3. EXHIBITOR SPACE Non-Profit Exhibitors who do not sell goods or products at the Event shall be provided with a 10 by 10 foot exhibitor space for no charge, to the extent space is available. Non-Profit Exhibitors not affiliated with District 181 who intend to sell goods or products at the event shall be charged \$50 (Fifty dollars) for use of the 10 foot by 10 foot space or, in lieu of the space fee, may donate product(s) or service(s) of comparable value for the Event raffle. Non-profit Exhibitors who intend to sell goods or products can rent additional space for \$50 (fifty dollars) per ten foot increment. The \$50 (fifty dollar) fee must be paid by a check made payable to the "District 181 Foundation" 30 (thirty) days prior to the Event, or by March 10, 2010. The raffle item or offering of a service must be provided on the *day of the event*.

4. WAIVER OF EXPENSES Non-Profit Exhibitor agrees to appear at the Event and to disperse information or market its product(s) at no expense to the Foundation. The Foundation represents to Non Profit Exhibitor that it is organized for purposes within the meaning of Section 501 (c) (3) of the Internal Revenue code.

5. HOLD HARMLESS Signing this contract is an agreement that the Non-Profit Exhibitor will not hold the Foundation responsible for theft, loss or damage to their property.

6. EXECUTION AND DELIVERY Non-Profit Exhibitor must return a signed copy of this Non-Profit Exhibitor Agreement along with their Exhibitor Space payment noted in paragraph 3 (if applicable) and the Display Table fee

noted in paragraph 6 (if applicable) by March 10, 2010 to constitute a valid execution and delivery of the Agreement.
